Faith's Gift

Faith Leonardson loved Mount Carmel. In fact, she had quite a history with Mount Carmel. You see, she was the daughter of the Dr. Samuel Miller, the President of the Lutheran Bible Institute in Minneapolis, MN that helped found Mount Carmel in 1938.

Faith and her husband, Otto were very generous to Mount Carmel. They rebuilt Cabin 29 with memorial money received after Faith's mom, Helene (Dr. Miller's wife) passed away. Otto also built all the beautifully crafted furniture for inside the cabin. In 1999 Faith gave \$30,000 to the M&M campaign. She also sponsored the Helene Miller concert series on Saturday nights.

Faith was 90 years old when she died in November 2016; she was able to live an independent life in her own house until then. Faith understood like few other people the dedication and passion her father had for building Mount Carmel. She witnessed this as a young girl and cherished her memories of that time and the stories her parents told her years later. She wasn't able to be at the 75th anniversary celebration for Mount Carmel in 2013 but sent her greetings and love for this ministry.

In March 2017 we received an email from Faith's son, Mark, with the news of Faith's passing. From the email, we learned that Faith had set aside a savings account to be donated to Mount Carmel upon her death. A few days later a certified check for \$300,000 arrived at Mount Carmel! What a legacy, what blessing!

- **Develop and Improve the Facilities** – Over the past twenty years, you have helped transform this modest family camp into a modern, beautiful campus that can serve in mission year round. We need to take the next step in modernizing our housing, grounds and facilities to maximize both summer and winter ministry.
- **Develop an Intern Program** – This will be the engine to help us fulfill the new vision! We can already see how the energy and talents of our Summer Staff can translate into powerful ministry. Imagine how an intern program will propel us forward in all of these initiatives! In return, they will gain valuable experience for future careers and a Christ-centered mentoring.

As we celebrate our 80th year of blessed ministry, all of this is pointing toward an exciting future for Mount Carmel, setting a strong foundation for another 80 years!
