Dear Proclaimers,

Why Mount Carmel?

The founders of Mount Carmel decided on a powerful name for this camp and ministry. It was chosen to be an identification and a challenge. One early description of this ministry by Samuel Miller explained it this way: "Like its biblical reference, it is located on a beautiful highland overlooking a body of water. As Elijah faced the prophets of Baal, here the Word of God challenges those who come to make a wholehearted surrender of themselves to the living God. The fire of the Holy Spirit continues to fall on the sacrifice of those who present themselves to God in the Name of Jesus Christ our Lord." (Adapted from the original 1938 booklet by Samuel Miller)

Mount Carmel has grown and become so much more than a few weeks of camp in the summer. The founders would marvel at how their dream and vision for a summer family camp has been transformed into a year round independent ministry. The *Daily Texts* continue to bring people together through common readings and prayers. Our international missional connections have enriched our summer camp experience. The *Walk Thru the Bible* seminars spread the Good News to congregations hungry for the Word. The Campus Ministry Community program helped equip students with a Christian world view to guide them in their life of faith.

2012 was a pivotal year of transition for Mount Carmel. We celebrated 28 years of vibrant ministry with the Hinderlies. We saw improvements to the campus with renovations on the west end, creating additional capacity for year round ministry. Beach renovations included the addition of stone jetties to decrease erosion, replacement of sand that was lost on beach front, and refurbishment of the pontoon boat with added handicap accessibility. The Campus Ministry Community served a total of 11 students, with 5 in 2011, and 6 in 2012. Program difficulties and financial challenges forced us to discontinue it in 2013, but we will continue to look to God to see where He might lead us with this kind of dream for ministry.

Faithful giving through the Hinderlie Leadership Fund and Annual Fund drives were wonderful blessings in a difficult financial year. We met our mortgage obligations and completed the necessary renovations and campus improvements, but we fell short of our budgeted goals and needs for operations. We look forward to your prayers and financial support, as we seek to bring honor and glory to God through all the ministries leading into the 75th year of God's grace at Mount Carmel. We can't do it without you.
