Dear Proclaimers,

I have been crucified with Christ. It is no longer I who live, but Christ who lives in me. And the life I now live in the flesh I live by faith in the Son of God, who loved me and gave himself for me. Galatians 2:20

St. Paul reminds us that to live is to die to one's self, to crucify our sinful desires, and to rise anew in Christ Jesus. This new life we now have is one that is lived out by faith, trusting in God's providence for all we have and do. Looking back on 2013 we can see how God was at work at Mount Carmel - blessings the lives of many through this Christ-centered and biblically-based ministry of rest and renewal.

God also gave us many opportunities to trust Him as it was a challenging year financially. Our Annual Fund donations dipped \$83,000 below an 8 year average and we were forced to take out a \$50,000 line of credit from the bank to cover the shortfall. It has since been repaid. We have eliminated some programs, trimmed operating expenses by \$90,000, are holding off on any new construction projects, and have renewed our focus on expanding our core family camp mission. The Board of Trustees adopted a balanced budget for 2014 that reflects realistic program and development goals and will closely monitor them throughout the year to make sure we are living within our means. Your strong and steady support will be key to the success of this ministry.

The Bearings Survey send out to Proclaimer's in early 2014 was the beginning stages of a three year strategic plan to make sure Mount Carmel is fiscally sound. The results from the survey were very encouraging, showing high satisfaction and strong loyalty, markers of a healthy ministry. We will be listening and responding to you throughout the summer through focus groups and individual conversations, gathering your feedback, so we can put together a comprehensive strategy and solid vision for the future.

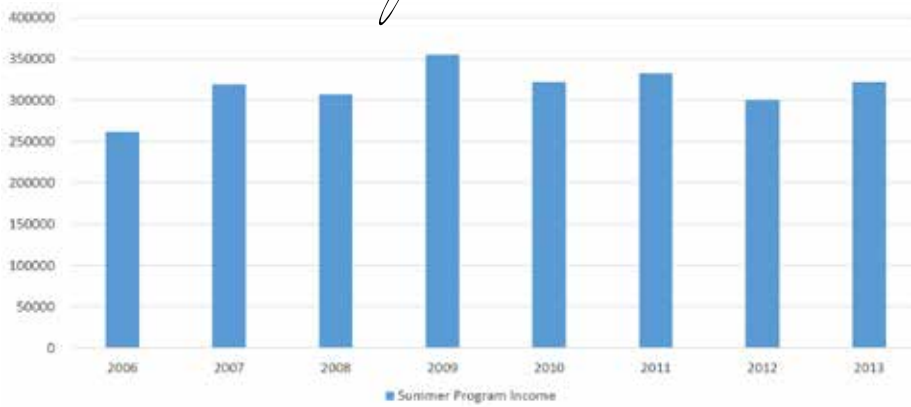

New staff members have brought new gifts and talents, which are just now beginning to mature and shine. Existing staff have provided stability, wisdom and a calm presence during periods of change. It has taken some time for us to find our new normal, develop as a team, and serve faithfully as we reach out with the Gospel. It does feel different, but we expected that, and you - the Mount Carmel faithful - have been patient and supportive. As we enter this new year we are prepared for the work God has called us to do. We look forward to witnessing the work He will do in the lives of those who experience our ministry.



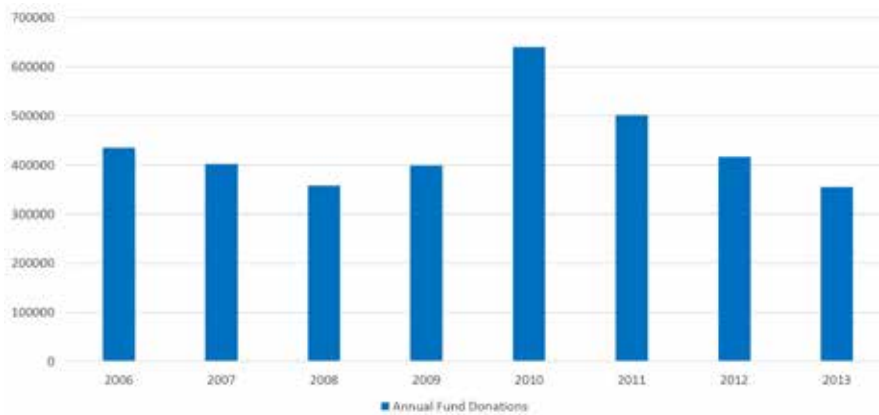

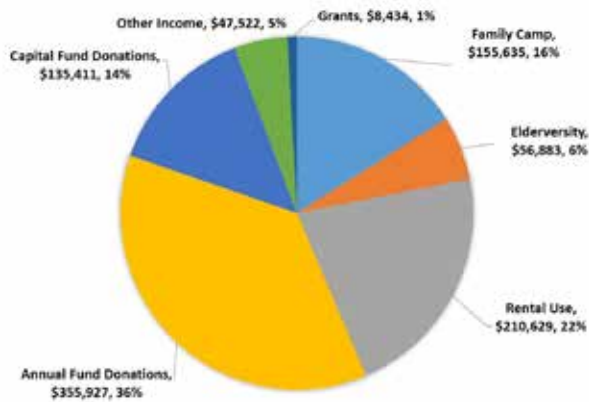
Program Revenue



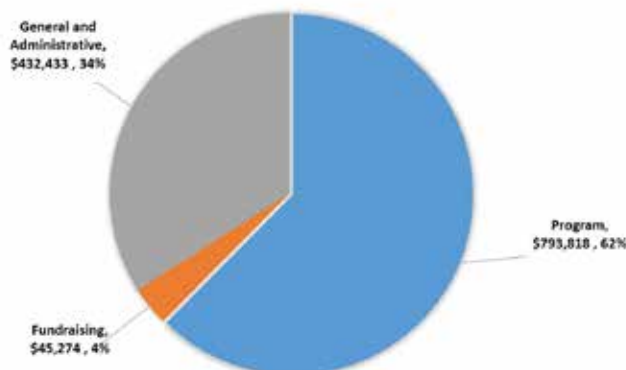
Annual Fund Donations
